U.S.I.S. RELEASE ON KASHMIR

- •411. Shri A. M. TARIQ: Will the Prime MINISTER be pleased to state:
- (a) whether Government have officially received a copy of U.S.I.S. release on Kashmir issued in Delhi on 22nd January, 1963; and
- (b) if so, what action Government have taken in the matter?

THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI DINESH SINGH): (a) and (b) Government did not officially receive a copy of the USIS release. There was, however, a Press release by the USIS on December 20th, 1962, which came to the notice of Government. Some parts of this release were considered factually not correct and otherwise rather improper. The matter was taken up verbally with the USIS authorities, who stated that the release did not represent the official views of the U.S. Government.

SRINAGAR—LEH ROAD

- ♦412. SHRI S. C. DEB: Will the Minister of DEFENCE be pleased to state:
- (a) whether the Srinagar-Leh Road would be opened to traffic early this year; and
- (b) if so, whether special equipment to make it an all-weather road has been acquired?
