SHRI DAHYABHAI V. PATEL: May I ask whether the Minister is in a position to inform us that this Mr. Sirajuddin's planned visit to Europe happens to be at a time when the Chief Minister of Orissa is also in Europe? Is it timed for this purpose? Has it got any relation to this question?

SHRI B. R. BHAGAT: This is an insinuation which I am unable to answer. It is worthy of the hon, Member himself to answer this question.
