THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI B. R. BHAGAT): (a) No. Sir.

Oral Answers

- (b) Does not arise.
- (c) Rs. 12.17 crores according to latest estimates.

SHRI P. K. KUMARAN: May know, Sir, what is holding up $\mathsf{thi}_{\mathtt{S}}$ agreement?

SHRI B. R. BHAGAT: Nothing is holding up the agreement. They are going into the matter. There are the project reports. Only procedural difficulties are there.

REPRESENTATION FOR THE EXEMPTION OF "THALI' FROM THE GOLD CONTROL ORDER

- *93. Shri A. D. MANI: Will the Minister of FINANCE be pleased state:
- (a) whether Government have received any representations for the exemption of the 'thali' or "tiruman. galyam from the provisions of the Gold Control Order: and
- (b) if so, what is the reaction Of Government thereto?

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI B. R. BHAGAT): (a) Yes.

(b) There is no religious or sacramental requirement that a 'thali' or 'tirumangalyam' should be in 22carat gold. No relaxation of the rules prohibiting the making, manufacture or preparation of gold ornaments having a purity exceeding 14carat has been made or is contemp. lated.

SHRI A. D. MANI: Sir, the Minister has said just now that there is no religious sanctity attached to the 'tirumangalyam' being made out of pure gold. Has Government taken the opinion of religious leaders like Sankaracharya?

SHRI MORARJI R. DESAI: That is not necessary; that is absolutely not necessary.

SHRI A. D. MANI: Has any proposal been received by Government that at least as far as the 'tirumangwhere a little alyam' is concerned, amount of gold is being used, Government may introduce a permit system and issue gold just as they issue permits for motor cars and scooters?

SHRI MORARJI R. DESAI: The two are not comparable.

SHRI B. D. KHOBARAGADE: May I know from the Government whether it is not a fact that there has been a custom which has acquired some sort of religious sanctity that 'tirumangalyam' should be in pure gold?

SHRI MORARJI R. DESAI: The sanctity which has been acquired by this custom of using gold for various purposes in this country has brought in many uneconomic results and loss to the country. Only in order to destroy that custom this step is being taken.

SHRIMATI DEVAKI GOPIDAS: May I know, Sir, the proportion of this 14-carat gold?

MR. CHAIRMAN: The question is not clear.

SHRIMATI DEVAKI GOPIDAS: May I know, Sir, the proportionate content of gold in this 14-carat gold?

SHRI MORARJI R. DESAI: It will be about 57 or 58 per cent. gold.

SHRI B. D. KHOBARAGADE: the 'tirumangalyam' is considered to be a sacred ornament, may I know, Sir, from the Government, 'tirumangalyam' is allowed to be

manufactured in pure gold, how much quantity would be required for this purpose?

SHRI MORARJI R. DESAI: It is not the question of quantity that may be required for this, but then it is difficult to specify one item for which pure gold will be allowed and not allowed for others. It will leave a loophole through which elephants can come in.

THE DEPUTY MINISTER IN THE MINISTRY OF HEALTH (DR. D. S. RAJU): (a) No. Sir.

(b) and (c) Do not arise.

SHRI M. P. BHARGAVA: May I know, Sir. whether it is a fact that one Dr. Mishra has been sent to England to study the National Health Scheme there?

DR. D. S. RAJU: Sir, it is Yes. true; he is an Assistant Directorunder Contributory General the Health Service Scheme.

SHRI M. P. BHARGAVA: May I know, Sir, whether this particular gentleman is on probation and was selected by the U.P.S.C. after waiving the advertised qualifications?

DR. SUSHILA NAYAR. Yes, Sir, he was selected by the U.P.S.C. There was an invitation from the W.H.O., who wanted us to depute an officer study hospital administration. social medicine, statistics, psychology, sociology, etc. etc. and we selected this officer.

Shri M. P. BHARGAVA: May I know, Sir, why this particular officer was selected when better highly qualified and permanent officials were available?

Dr. SUSHILA NAYAR: Yes. it was considered by all concerned in the Selection Committee that he was the most competent officer for job for which one was to be selected.

Mr. CHAIRMAN: For the kind of training for which he was proceeding.
