THE MINISTER OF HOME AF-FAIRS (SHRI LAL BAHADUR); (a) and (b) The information is being collected from the State Governments and will be laid on the table of the House when received.

VIJNAN MANDIRS

- *161. SHRI M. P. BHARGAVA: Will the Minister of Scientific Re-SEARCH AND CULTURAL AFFAIRS be pleased to state:
- (a) the total number of Vijnan Mandirs working in the States on the 31st January, 1963;

- (c) One has already been established. Further establishment of Vijnan Mandirs would depend upon availability of funds and provision of suitable buildings with necessary facilities by the State Governments.

SPORTS GOODS PURCHASED BY DIRECTO-RATE OF EDUCATION, DELHI

- (a) whether it is a fact that sports goods worth thosands of rupees were purchased by the Directorate of Education, Delhi, on behalf of schools during the year 1961-62;

THE MINISTER OF EDUCATION (Dr. K. L. SHRIMALI); (a) Yes, Sir.

- (b) Tenders were invited by notice from local dealers of sports goods.
- (c) No, Sir, because the demands of the various schools for sports goods were otherwise known to the Directorate.

GRANTS TO VOLUNTARY ORGANISATIONS FOR PROMOTION OF HINDI

- *163. SHRI A. M. TARIQ: Will the Minister of Education be pleased to state:
- (a) the amount of grants given to voluntary organisations and individuals working for the development of Hindi during the year 1962; and
- (b) how it compares with that given in 1961?

THE MINISTER OF EDUCATION (DR. K. L. SHRIMALI): (a) and (b) Grants amounting to Rs. 3,41,175 have been given to-date during 1962-63 to Voluntary Hindi Organisations for the propagation and development of Hindi against a sum of Rs. 2,91,949 given during 1961-62.

COAL PRICES

- *164. SHRI S. PATEL: Will the Minister of Mines and Fuel be pleased to state:
- (a) whether Government propose to overhaul the system of fixing coal prices; and
- (b) if so, what are the details of the proposal? 3.

THE MINISTER OF MINES AND FUEL (SHRI K. D. MALAVIYA): and (b) Government are at present considering the report of an Experts Committee which has suggested grading of coals on the basis of calorific value. If this suggestion is implemented, the price structure of coal will have to be fitted in with the new classification, but there is no question of overhauling the price structure by itself_

CUT IN THE COST OF STEEL PRODUCTION

- *165. SHRI PANNALAL SAROGI: Will the Minister of STEEL AND HEAVY INDUSTRIES be pleased to state:
- (a) whether Government have decided to cut the cost of production of steel in the Public Sector; and
- (b) if so, what are the details of the scheme drawn up in the matter?

THE MINISTER OF STEEL AND HEAVY INDUSTRIES (SHRI C. SUB-RAMANIAM): (a) and (b) Measures to reduce the cost of steel production and expedite the movement of endproducts are constantly under review. Steps are taken to rationalise the working and the methods of production so as to achieve reduction in cost. These matters were also considered in a recent meeting with the General Managers and Directors of Hindustan Steel Ltd. When their attention was drawn to the need for cost reduction and the examination of measures to that end.
