Will the Minister of- PETROLEUM AND CHEMICALS be pleased to reier to the reply given to Starred Question No. 534 in the Rajva Sabha on the 10th September, 1965 and state whether any progress has been made in attempts to arrive at a collaboration agreement for setting up the Haldia Refinery?

THE MINISTER OF PETROLEUM AND CHEMICALS (SHRI HUMAYUN KABIR): The proposals received are under detailed technical scrutiny.

PRATAP **RAJENDRA** SHRI From where SINHA: have you received the proposals?

SHRI HUMAYUN KABIR: Thete is one proposal from a combination of a German firm and an American firm, Phoenix Mobil. The second proposal is from Rumania, Industrial Export of Rumania, and .the third proposal is from C.F.P.; France. And we have heard-but we have not yet received any proposal-that a Japanese consortium also wishes to submit a proposal.

SHRI RAJENDRA PRATAP SINHA: Do you propose to wait till you receive the Japanese proposal?

MR. CHAIRMAN: Just a minute Mr. Ram Gopal Gupta.

SHRI RAMGOPAL GUPTA: When do you think this project will be finalised and if you wait for the Japanese propsal will it not delay the overall scheme quite considerably?

SHRI HUMAYUN KABIR: These negotiations do take some time I admit but we will not wait indefinitely. The German proposals have been examined; most of the detailed scrutiny is over. The C.F.P. proposals and the Rumanian proposals are under examination. As soon as we receive a proposal which we consider to be to the advantage of India we shall clinch the matter and we shall not wait for any new proposals.

SHRI RAMGOPAL GUPTA.- Will the proposal go through in spite of the fact that priorities in the Fourth Plan are being changed?

SHRI HUMAYUN KABIR: Sir, the •hange of priorities in the Fourth Plan will help .the proposal rather than otherwise.

SHRI BIREN ROY; Last time in reply to one of my supplementaries the hon. Minister stated that there was also a proposal from Rumania that being an East European country with which we have a rupee account I would like to ask if the scrutiny that is now being made will involve whether we will save foreign exchange by collaboration with an East European country or we shall go further foreign exchange expenditure by collaboration with some West European country.

SHRI HUMAYUN KABIR: .My hon. friend is probably aware that in the case of project like this, the projects bring their "own foreign exchange. Some payment has to be made in any ease; whether it is through rupee

foreign exchange or through free foreign exchange we shall take the proposal which is most advantageous to the country and naturally weightage will be given to the fact that in the case of Rumania a large part of the payment will be made in rupees.

SHRIMATI LALITHA (RAJA-GOPALAN): May I know from the hon. Minister which country is willing to meet the foreign exchange requirements of this collaboration?

SHRI HUMAYUN KABIR: I have just now stated that everyone who makes an offer comes with the foreign exchange attached to the offer.

SHRI G. MURAHARI: I would like to know from the Government whether the Government is also looking into the political aspect of this collaboration because the West German Government is known to have supplied a large quantity of arm_s. to Pakistan and any collaboration with West Germany would only work to our detriment. I would like to know from the Government whether this aspect oC the problem is kept in view when taking a final decision in the matter.

SHRI HUMAYUN KABIR: All aspects will be taken into consideration and as I have stated earlier the proposal which is to the greatest advantage of India will be accepted. We should not go about looking out for enemies and making sometimes our friends turn enemies.

SHRI A. D. MANI; Would the Minister give information about the nature o:: control which the European collaborators would like to have in the setting up of the refinery? Would they allow the refinery to be set up by Indians or would they like to retain control over every aspect of the setting up of the refinery?

SHRi HUMAYUN KABIR: These are details under negotiation and while thri negotiations are in progress

I do not think it will be in public interest to divulge all the details. I can assure the hon. Member and the House that any proposal which we accept shall be in the interests of the country and the arrangement for the control of the refinery will also be in the interest of the country.

SHRI I. K. GUJRAL: May I ask the Minister if while finalising the arrangement with any group or with any countries this factor will also be kept in view of aggression by Pakistan and it is not repeated again that those countries stop the arrangement leaving it in mid air whenever they wish and may I know whether any clause will be put in the agreement that this sort of thing does not happen again?

SHRI HUMAYUN KABIR: I do not think any project which we have

undertaken has been stopped because of this and again we should not anticipate but every precaution will be taken to see that our interests are safeguarded.
