Indian Air Force Personnel sent to Congo

\*149. SHRIMATI SAVITRY DEVI NIGAM: Will the Minister of DEFENCE be pleased to state the number of Indian Air Force personnel sent to Congo during the last three months?

THE MINISTER OF DEFENCE (SHRI V., K. KRISHNA MENON): 147 Air Force personnel were sent to Congo during the last three months *i.e.* from 1st August, 1961 to 31st October, 1961.

Shrimati Savitry Devi Nigam: May I know if special care is taken to see that those people who go from here are looked after properly and that they are given enough security?

SHRI V. K. KRISHNA MENON: Sir, the forces placed at the disposal of the United Nations by this country are in order to take security measures over there. We cannot say with regard to the other troops.

SHRIMATI SAVITRY DEVI NIGAM: May I know whether these people who go there in such circumstances are given any special allowances?

Shri V. K. KRISHNA MENON: There are allowances which are regulated by agreements with the United Nations. They are governed by Air Force Rules. There are no other special allowances in this matter.

SHRI T. S. AVINASHILINGAM CHETTIAR: May I know whether it is true—we heard a recent report—that at least one of our Air Force personnel was missing and whether any enquiries were made, and what is the latest position?

SHRI V. K. KRISHNA MENON: I have not heard anything of the kind.

SHRI N. SRI RAMA REDDY: May I know whether the Indian Air Force personnel were involved in any encounter in the Congo and, if so, whether there were any accidents or casualties?

SHRI V. K. KRISHNA MENON: I have not heard of any casualties in the Air Force so far.

Shri NAWAB SINGH CHAUHAN: May I ask whether the hon. Minister has seen the statement made by the Irish representative Mr. O'Brian, who has just resigned merely out of contempt for the attitude which the French and the British have adopted?

MR. DEPUTY CHAIRMAN: It is a matter for a separate question. This is about Air Force personnel

SHRI NAWAB SINGH CHAUHAN: Air Force and all Forces.

MR. DEPUTY CHAIRMAN: You can table a separate question for that.

Pandit S. S. N. TANKHA: May I know whether the salaries of these Air Force men or other personnel sent out from India are being paid by the Indian Government or their salaries and allowances are paid by the U.N.?

Shri V. K. KRISHNA MENON: The normal salaries are paid out of the Indian revenues. Anything additional that is incurred by the Government of India is reimbursed by the U.N.

#### STATEMENT

Ordnance Factory employees and their families are entitled to treatment in Ordnance Factory pitals. There are no facilities for special treatment of T. B. in hospitals. In order to provide facilities for treatment to T. B. patients, a Fund called the Defence Civilians Welfare (TB) Fund has been started. Membership of this Fund is open to all Defence employees on payment of subscriptions ranging from annas 2 per month to Rs. 2 per month according to emoluments. The Fund provides domiciliary treatment for its members and their families in T. B. Clinics run by the Fund, institutional treatment for members in beds reserved in T. B. Sanatoria and financial help for nutritious food and "after-care" of T. B. patients among Defence employees and their families. The Fund has reserved beds in T. B. Sanatoria as under:-

- (i) Kasauli .. 22 beds.
- (ii) Aundh .. 10 beds.
- (iii) Hyderabad .. 5 beds.
- (iv) Jadavpur (Calcutta) 5 beds.
- (v) Coimbatore 3 beds.

फौजी सामान के कारखानों के कर्मचारों ग्रीर उन के परिवार कारखानों के चिकित्सालयों में निःशुल्क इलाज के अधिकारी हैं। इन अस्पतालों में क्षय-रोग की विशिष्ट चिकित्सा के लिए कोई सुविधाएं नहीं हैं। क्षय रोगियों को सुविधाएं प्राप्य करने के लिये डिफन्स सिविलियन्स वेलफेयर (टी.

बी.) फण्ड नाम का एक फण्ड चालू किया गया है । आय के अनुसार २ आना प्रतिमास से लेकर २ रुप्ये प्रतिमास सदस्यता शुल्क की अदायगी पर, इसकी सदस्यता सभी प्रतिरक्षा सेवी वर्ग के लिये खुली है । यह फण्ड सदस्यों और उन के परिवारों को, इस फण्ड से चालू क्षय चिकित्सा केन्द्रों द्वारा, उन के वास्य स्थानों पर, क्षय चिकित्सा प्राप्य करना है, क्षय-प्रारोग्य- शालाओं में अपने सदस्यों के लिए बिस्तर सुरक्षित कर के संस्था-चिकित्सा प्राप्य करता है, और प्रतिरक्षा सेवी वर्ग और उनके कुटुम्बों में क्षय-रोग्यों के लिए गीयक-बुराक और उत्तर-अवेक्षा के लिए आर्थिक सहायता भी।

श्री जवार्बासह चौहान: क्या यह सच है कि इस वक्त भी बहुत से ऐसे टी० बी० पेशेन्ट हैं जो न्योर हो गये हैं लेकिन उन्हें स्रभी तक लाइट वर्क नहीं दिया गया हैं?

MR. DEPUTY CHAIRMAN: Please ask him in English. He does not follow Hindi.

Shri NAWAB SINGH CHAUHAN: Is it a fact that many such T. B. patients who have been cured have not been given light work?

SHRI K. RAGHURAMAIAH: I have given the number of persons cured. The total number of patients are 887 and the number of persons cured is 431.

Shri NAWAB SINGH CHAUHAN: May I know whether such persons have been given light work because as a rule those who are cured of T. B. must be given light work and not hard work?

Shri K. RAGHURAMAIAH: Every facility is given. This refers to cases of persons actually sent to sanatoria and cured there and wherever it is possible to give light work, naturally, every consideration is given.

SHRIMATI SAVITRY DEVI NIGAM: May I know if the Minister is aware that many of these T.B. patients who have been cured have been given reemployment in the factories but unfor unately they are not being given light work which has been prescribed in the rules?

SHRI K. RAGHURAMAIAH: If there are any such specific cases, I shall be grateful if the hon. Member would furnish them to me. I shall look into them.

SHRIMATI T. NALLAMUTHU RAMAMURTI: Is there any special circumstance that creates T.B. patients? May I know the reason why there are so many T.B. patients in these Ordnance Factories?

SHRI K. RAGHURAMAIAH: We are dealing with lakhs of employees and there is nothing very specially hazardous in the nature of work done in the Ordnance Factories. Things do happen.

SHRI FARIDUL HAQ ANSARI: Shrimati Nigam asked the number of patients who have been given hard work after they were cured. May I know whether the Minister has no knowledge about these persons?

MR. DEPUTY CHAIRMAN: He said that if any particular instance is brought to his notice, he will enquire. He said that every facility is being given.

SHRI FARIDUL HAQ ANSARI: I want to know whether he has know-ledge of it or not.

Shri K. RAGHURAMAIAH: I have no information at the moment. If there are any contraventions of any rules in any particular case and unduly hard work is given, if there are any such cases, certainly I shall be happy to look into them and do the needful.

Shrimati Savitry Devi Nigam:
May I know if the Minister is aware
that there are some jobs in the Ordnance Factories like those in the
Sawmill section where the cases of
T. B. incidence, are quite large as
compared to other departments? If
the answer is in the affirmative, then
I would like to know whether any
special allowance is being given to
the workers in those sections to give
them a little more nourishment or
not.

Shri K. RAGHURAMAIAH: T. B. is not confined to any particular factory. Therefore, the question of any special allowance in any particular factory has not so far arisen.

KUMARI SHANTA VASISHT: Is it not a fact that the patients who are under treatment in a T.B. hospital, after they are cured, are given var ous categories like A, B, C, etc. and then work is allotted to them according to the category in which they are placed?

SHRI K. RAGHURAMAIAH: This more or less relates to a question that has been put and already answered.

†[PARKING OF MILITARY VEHICLES IN THE OPEN

\*155. SHRI NAWAB SINGH CHAU-HAN: Will the Minister of DEFENCE be pleased to state:

- (a) whether it is a fact that a large number of military trucks, jeeps and other vehicles are parked in the open during summer, winter and rainy season in Delhi Cantonment;
- (b) if so, the number of vehicles parked in the open and the damage caused to them by parking them in the open;
- (c) the arrangements which are being made to provide covered accommodation; and
- (d) whether it is a fact that similar conditions obtain in other cantonments also and if so, the total number of vehicles and the quantity of other goods which are lying in the open?]

THE DEPUTY MINISTER OF DEF-ENCE (SHRI K. RAGHURAMAIAH): (a) Yes, Sir.

(b) It would not be in public interest to disclose the number of vehicles held in the Depot under cover and in the open. By keeping vehicles in the open, a certain amount of deterioration does take place but
