- (a) whether Government have received any representation from the inhabitants of Manipur including Nagas for the merger of Manipur with Nagaland; and

THE MINISTER OF HOME AFFAIRS (SHRI LAL BAHADUR): (a) A memorandum has been received from the Manipur Naga Council suggesting the integration of Naga areas in Manipur with Nagaland.

(b) Government of India is not considering the making of any territorial changes in Manipur or Nagaland.
