PUSH-BUTTON SAFETY DEVICE IN LADIES COMPARTMENT OF TRAINS

## (a) Yes, Sir.

(b) and (c) The main purpose for providing this device is to make easier for passengers in ladies compartments to raise alarm in distress and to facilitate stoppage of the train by the crew and passengers in such cases. The push-button switch provided below the alarm chain handle in ladies compartments, when pressed in case of an emergency (i) operates an alarm bell and lights a red lamp in the Guard's compartment, (ii) switches "on" an amber exterior light outside on both sides of the ladies compartment, and (iii) sounds electric horn in the adjacent gents compartment. On hearing the bell, the Guard is to stop the train by the application of vacuum brakes from his compartment. The amber lights outside the ladies compartment are provided to facilitate identification of the compartment from which the distress signal has emanated. Sounding of the electric horn in the adjacent compartment enables passengers in that compartment to rush quickly for assistance to the ladies compartment

The alarm chain device, when operated, applies brakes partially on the train, to be followed by full application of brakes by the Guard or the Driver. On the other hand application of the push-button safety device serves to attract attention of the Guard and fellow passengers in the adjoining compartment to apply the brakes and stop the train quicker time and come to the rescue of the lady passenger.
