Schedule £.—Preparations containing schedule E drugs shall be labelled with the word "Poison" either in red lettering or against a red background. Preparations for internal use containing a Schedule E drug in concentration les, than the exempted limit but whose dosages should not exceed the level stated shall be labelled with, "Caution. It is dangerous to exceed the stated dose."

Schedule G.—Preparations containing schedule G drugs shall be labelled, "Caution: It is dangerous to take this preparation except under medical supervision."

Schedule H.—Preparations containing schedule H drugs shall be labelled with 'Poison' in red lettering or against red background and also with the word "Schedule H Drug: Warning: To be sold by retail on the prescription of a Registered Medical Practitioner only."]
