The increase became effective from 1st April 1958. The increase is Rs. 10 p.m. for pensions up to Rs. 50 p.m.; Rs. 12.50 p.m. for pensions above Rs. 50 and not exceeding Rs. 100 p.m. A marginal increase has been sanctioned for pensions above Rs. 100, to permit their enhancement up to Rs. 112.50 p.m.

RESTRICTIONS ON TRANSFER OF SHARES OF NEW ISSUES

BHAGAT): (a) 'and (b) When a newly floated company wants to reserve a block of shares for private allotment to promoters, directors, their friends and associates, an assurance is usually obtained from the company that the shares thus reserved for private subscription are alloted to persons who would be genuinely interested in the long term investment in the company and would not dispose of the shares for the sake of immediate capital gains for a specified period. The period usually from two or three years. Where, however, the entire issue is thus sought to be reserved, the period is five years.

## STATEMENT

- (a) The present scales of pay prescribed for language teachers in Government schools are as follows:—
  - Language Teachers Grade I (for Class XI only)—Rs. 250—470.
  - Language Teachers Grade II—Rs. 170—380
  - Language Teachers Grade III— (for Middle Schools)—Rs. 160—300.

There were certain teachers in Government schools at the time of revision of scales of pay and qualifications in 1950 who did not possess the qualifications prescribed for the various grades. The interests of such teachers who were in service on 1st April, 1950 were protected but they were given the following lower scales of pay as personal to them according to their individual qualifications:

- Rs. 100—250.—Since revised to Rs. 160—300.
- Rs. 80—220.—Since revised to Rs. 130—300.
- Rs. 68—170.—Since revised to Rs. 118—225.
- (b) and (c) The scale of Rs. 68—170 (and not Rs. 68—175) has since been revised to Rs. 118—225. There is only one language teacher in this scale. He
