THE MINISTER OF INFORMATION AND BROADCASTING (DR. B. V. KESKAR): (a) and (b) Government have seen reports of the speeches made by the Prime Minister of South Africa both in South 'African and Indian newspapers. No authentic information about these speeches and statements is, however, available with Government, as there is no Indian Mission in South Africa.

HAJI AHMAD JAN WAKF-UL-AULAD TRUST \*270. DIWAN CHAMAN LALL: Will the Minister of REHABILITATION be pleased to state:

- (a) whether it is a fact that the entire property of Haji Ahmad Jan a "Wakf-ul-Aulad Trust, has been allotted by Government to one Sardar Begam, whose name does not appear in the Trust Deed; and
- (b) if so, what are the reasons for such action?

THE MINISTER OF REHABILITATION AND MINORITY AFFAIRS (SHRI MEHR CHAND KHANNA): (a) The properties in respect of which Haji Ahmad Jan created a Wakf-alal-Aulad Trust have been released (not allotted) in favour of Shrimati Sardar Begum *alias* Sardar Jahan daughter of the *wakij*, who is the only non-evacuee beneficiary of the *wakf*. Her name appears in the *wakf* deed as Mst. Sardar Jahan daughter of the *wakij* and v-fe of Mohammed Saeed of Kalkatte-Wale.

(b) Wakf-Alal-Aulad Trusts are primarily meant for the benefit of the descendants of the *wakif*, but they also contain a provision for charity and are ultimately dedicated to God. There are a number of cases in which some of the beneficiaries have migrated to Pakistan while others have remained in India. These properties cannot be acquired under the Compensation Act, because they involve interests of charity and non-evacuee beneficiaries. It has, therefore, been decided to relinquish the evacuee |

beneficiaries' interest in such properties in favour of non-evacuee beneficiaries.
