THE DEPUTY MINISTER OF AGRI-CULTURE (SHRI M. V. KRISHNAPPA): (a) Yes. About a hundred local mechanised fishing boats are already carrying out fishing operations in the area.

- (b) About three miles. No representation has been recieved.
- (e) Details have not been worked out. This project forms part of a major scheme of exploratory and experimental fishing for the survey and charting of fishing grounds in Indian waters based at different Centres along the coast.

SHIFTING OF MINERAL SIDING, NEW DELHI

- *310. SHRI SHERKHAN: Will the Minister of RAILWAYS be pleased to
- (a) whether it is a fact that there is a proposal under Government's consideration to shift the New Delhi Mineral Siding to some other place;
- (b) if so, what is the proposed location of the site to which it will be shifted; and by when it is likely to be completed;
- (c) what is the area and capacity of the present siding and what will be the area and capacity of the siding proposed to be opened; and
- (d) what benefits are expected to accrue to the public and to the Railways as a result of opening of the new siding?

THE DEPUTY MINISTER OF RAIL-WAYS (SHRI S. V RAMASWAMY): (a) Yes, Sir.

- (b) It is proposed to shift it to a site about 11 miles north of Tughlakabad station. The proposal is however, still under examination
- (c) The present mineral yard at New Delhi consists of 9 lines of a

total length of 6937 Lft., spread over an area of about 25 acres. It is proposed to provide in the first phase, 5 lines totalling 5000 Lft. in the new yard spread over an area of about 22 acres, which would be capable of dealing with the entire coke and coal traffic. Later on, the capacity would be suitably expanded in order to shift the entire mineral yard work from New Delhi.

(d) The public and the Railways will be benefited by way of greater facility for handling larger quantities of mineral traffic and the removal of congestion in New Delhi Yard.
