(d) Attempts are being made to prevent breaches by raising the road level and diverting the flow of storm water.

DIVERSION OF COAL BY CONSIGNEES TO OTHER STATIONS IN DELHI AREA

- *303. SHRI LILA DHAR BAROOAH: Will the Minister of RAILWAYS be pleased to state:
- whether it is a fact that in. certain cases of misloading of coal, the wagons were not placed in the mine ral siding at Delhi and diverted to other stations for release by con signees during the months of October, 1960 to January, 1961;
- (b) if so, what are the names of such stations and what is the number of the wagons so diverted to each station;
- whether this diversion was arranged under any instructions from the Department of Civil Supplies, Delhi; and if so, what were the ins tructions and whether anv extra freight was received from the cons'gnees; and if so, what was the amount thereof: and
- (d) what is the capacity of the mineral siding at Delhi?

THE DEPUTY MINISTER OF RAIL-' WAYS (SHRI S. V. RAMASWAMY): (a) and (b) 21 and 9 wagons originally consigned to New Delhi Mineral Siding were diverted to Delhi Safdarjang at the request of the consignees during the months of October, 1960 and November, 1960 respectively. None of these wagons was a case of misloading.

- (c) Civil Supplies Department had recommended acceptance of requests for diversion to facilitate quick release of wagons and avoidance of congestion at the New Delhi Mineral S ding. Rs. 330 and Rs. 136-75nP were collected in respect of all the 30 wagons towards diversion fee and undercharges respectively.
 - (d) 212 wagons.

MISLOADING OF COAL IN DELHI AREA

- (a) the number of cases of misloading, e.g. of steam coal, slack coal and hard coke in place of soft coke, which were detected by railway authorities from October, 1960 to January, 1961 at the stations in Delhi territory and what is the number of wagons involved;
- (b) what is the amount recovered from the concerned consignees due to difference of rates in booking;
- (c) what are the names of the consignees and how many wagons each consignee had in his name;
- (d) what act'on has been taken or is proposed to be taken by the railway authorities against this irregular booking; and
- whether any list of consign ment, consignors and consignees" in volved in this irregular booking was sent to the Civil Supplies Authorities, Delhi, and the Coal Controller, Cal cutta, for necessary action; if so, with what results?

THE DEPUTY MINISTER OF RAILWAYS (SHRI SHAH NAWAZ KHAN): (a) 287 wagons described as soft coke and one wagon described as hard coke were detected improperly described and found to contam 89 wagons loaded wi;h hard coke, 96 wagons with slack coal and 103 wagons with steam

- (b) Rs. 1541.95 nP. comprising of Rs. 1131 towards undercharges due to difference in the minimum weight for charge and Rs. 410.95 nP. towards central cesses,
- (c) A list of consignees and the number of wagons each consignee had in his name is laid on the Table of the House.
- (d) The Eastern Railway and the Coal Controller have been asked to take suitable remedial action.

(e) Yes, to the Coal Controller who is being asked to advise the action taken. No report was sent to the Civil Supplies Department since as a result of their regular checks the matter is already within their knowledge.
