DISPENSARIES WITHOUT DOCTORS IN RURAL AREAS

•305. SHRI S. C. DEB: Will the **Minister** of HEALTH be pleased to state:

(b) if so, what are the steps that are being taken by Government to meet the situation?

THE MINISTER OF HEALTH (SHRI D. P. KARMARKAR) : (a) No such assessment has recently been made by the Central Government.

PROSPECT OF PADDY CROP

•306. SHRI S. C. DEB: Will the Minister of FOOD AND AGRICULTURE be pleased to state the prospect of paddy crop in the paddy-growing States of the country?

THE DEPUTY MINISTER OF AGRI-CULTURE (SHRI M. V. KRISHNAPPA) : The production estimates of paddy crop in the country during 1961-62 have not become available so far. The prospects of the paddy crop for the country as a whole appear to be satisfactory. The crop in the Southern region is better than in the rest of the country.

SHRI S. C. DEB: May I know whether it has been brought to the notice of the Government that there has been insect harm done to paddy in some parts of the country?

SHRI M. V. KRISHNAPPA: We have received reports from various parts of the country that there were insect pests attacking the paddy crop.

SHRI S. C. DEB: In that connection, what remedial measures were taken?

SHRI M. V. KRISHNAPPA: Yes, Sir. The State Agricultural Departments immediately take action to meet the situation.

SHRI T. S. AVINASHILINGAM CHETTIAR: Sir, recently there were reports—and we ourselves saw them— of large swarms of locusts which went over Delhi.

Mn. DEPUTY CHAIRMAN: This is about the paddy crop.

SHRI T. S. AVINASHILINGAM CHETTIAR: This may affect the paddy crop.
