## EXPENDITURE INCURRED ON THE DOCU-MENTARY FILM ON "KASHMIR"

THE MINISTER OF INFORMATION AND BROADCASTING (DR. B. V. KESKAR): (a) About Rs. 1,28,000 out of which a sum of Rs. 1,00,108 was paid to Shri Rajbans Khanna, producer of the film and the remaining sum of about Rs. 28,000 was spent on dubbing the film in 12 languages for its release in cinemas.

- (b) Rates vary depending on different factors like the nature of subject, the amount of travelling involved, the number of people engaged, the standing of the Director, and so on. During 1958-59 when this film was assigned to Shri Khanna, the usual rate was between Rs. 15 and Rs. 20 per foot.
  - (c) Rs. 33 43 nP per foot.

- (d) and (e) The longer version of the film was finally approved in November 1959 and the shorter one (meant for release on cinema circuits in India) in February 1960. Prints of both the versions in English were delivered by the producer in March, 1960.
- (f) The English version was released in cinemas in India on the 13th October, 1961 and the versions in other languages which got ready later on the 17th November, 1961.
