**MANUFACTURE OF TEXTILE MACHINERY**

275. SHRI RAMGOPAL GUPTA: Will the Minister of COMMERCE AND INDUSTRY be pleased to state:

(a) whether the Study Group formed last year for evolving a phased programme of manufacture of textile machinery items within the country has since submitted its report; and

(b) if so, what steps Government have taken or propose to take to ensure that the production of textile machinery goes entirely in accordance with the programme prepared by the Study Group?

THE MINISTER OF INDUSTRY (SHRI MANUBHAI SHAH): (a) Not yet,

(b) After the production programme for textile machinery for the Third Plan period is finalised, Government would give all possible assistance to the manufacturers of the machinery, in regard to capital equipment, components and raw materials, to implement the approved programmes. It may, however, be added that recently a conference was held with textile machinery manufacturers-in order to accelerate the manufacturing programmes already approved by Government for the manufacture of textile machinery. It is hoped that during the Third Plan period it would be possible to meet the major portion of the textile machinery required from out of indigenous production.
