THE MINISTER OF INFORMATION 1 AND BROADCASTING (DR. B. V. KESKEH): (a) and (b) Applications for admission to the first regular courses in the Film Institute were invited through an advertisement which appeared in various newspapers. These applications were scrutinized by a committee consisting of the Principal and the Professor concerned and those candidates who did not satisfy the prescribed qualifications etc., were rejected straightaway. Out of the eligible candidates, those who had secured a higher percentage of marks in the qualifying examination, were called for interview before a committee which made the final selection for admission. The committee consisted of:

- 1. Principal,
- 2. Professor concerned,
- 3. An expert on the subject from the film industry, and
- 4. Officer on Special Duty, Film Institute of India.

In future it is proposed to hold both written as well as oral tests for selection of candidates.
