SUBBARAYAN: The Pay Commission have not specifically recommended that the stenographers attached to the Directors, P. & T. should be in the scale of Rs. 210/425 but since they have observed that the stenographers attached to the officers whose duties and responsibilities are comparable to those of the Deputy Secretaries of the Government should be in the scale of Rs. 210/425, the D. G., P. & T., has taken up the proposal that the pay of the stenographers attached to the Directors, P. & T., whose duties and responsibilities are comparable to those of a Deputy Secretary of Government of India. should be in the scale of Rs. 210/425 as against Rs. 130/300, the scale. The proposal is being examined by the Ministry of Finance. No final decision has so far been taken in the matter, but from the trend of discussions in the Ministry of Finance, favourable decision is really expected.

## STOPPING OF TRAINS AT SAHIBABAD STATION

\*396. Shri DEOKINANDAN NARA-YAN: Will the Minister of RAILWAYS be pleased to state:

- (a) whether it is a fact that some students stopped trains at Sahibabad Station on the 28th November, 1961;
- (b) if so, what were the reasons for this incident;
- (c) for how long the trains detained; and
- (d) whether police were called in that connection?

THE DEPUTY MINISTER OF RAIL-WAYS (SHRI S. V. RAMASWAMY): (a) Yes, Sir.

(b) Late start of 1 GND Down Ghazia/bad-New Delhi Shuttle by 10 minutes Ghaziabad on ex. account of engine being train detained at the Loco passage, and detention of the train at Sahibadad due to the failure of the train engine.

(d) The Civil Authorities of Ghaziabad and Meerut were informed about **t**he situation Sahibabad. At at about  $13 \cdot 30$ the District Magistrate. Meerut accompanied by the District Superintendent of Police and a posse of U. P. Police and U. P. Armed Constabulary arrived at spot.

SHRI DEOKINANDAN NARAYAN: May I know if it is a fact that students have a long standing grievance against the trains running late between Ghaziabad and Delhi?

SHRI S. V. RAMASWAMY: It is not long standing one. As a matter of fact, the trains were running to time almost in September, October and in the early part of November. But later on, due to shortage of coal that being due to the Puja holidays and due to the bad quality of coal, there trouble with the engines, and only for sixteen days there was some delay in the running of trains.

SHRI DEOKINANDAN NARAYAN: May I know what was the assurance which was given to these students by the District Magistrate when stopped trains one after another?

SHRI S. V. RAMASWAMY: Earlier, even the railway officials themselves had said that they would try do their u'most to run the trains to time. The difficulty was due to the bad quality of the coal.

SHRI DEOKINANDAN NARAYAN: I wanted to know what assurance was given by the District Magistrate when he came and asked the students to remove themselves from the platform?

SHRI JAGJIVAN RAM: They were told that every effort would be made to run the trains on time.

SHRI FARIDUL HAQ ANSARI: As the hon. Minister must be aware, it is not the first time that such an ille-

gal thing has happened. May I know what action the civil and railway authorities took against the people who indulged in these illegal actions?

SHRI JAGJIVAN RAM: It is a difficult question and a bigger problemthe conduct of the student community in certain sections of the When a large number of students are involved, it becomes very difficult to take legal action and deal with the tak ng legal action offenders by against them.

SHRI DEOKINANDAN NARAYAN: May I know how many students go from Delhi to Ghaziabad and from Ghaziabad to Delhi back, and how many of them are ticketless?

SHRI JAGJIVAN RAM: It is very difficult to say how many students go every day from Delhi to Ghaziabad or vice versa.

SHRI B. P. BASAPPA SHETTY: May I know whether the students are not issued season tickets, and it is not the duty of the railway authorities to see that some alternative arrangements are made to enable the students to reach their places in time?

SHRI JAGJIVAN RAM: For those who want to purchase season tickets, season tickets are sold to them. But in the very nature of things as explained by the Deputy Minister, when there was some shortage of coal in the Ghaziabad loco-shed and the quality of the coal was not according to the specification for consumption by the locomotives, their speed was affected. And action has been taken since then, and I have not heard of complaint till now. I have been personally watching it.
