

**श्री पा० ना० राजभोज :** क्या माननीय मंत्री महोदय जी कृपा कर के बतायेंगे कि क्या सरकार इस बात के लिए एन० डी० एम० सी० को कुछ ग्रांट्स देने वाली है ?

SHRI ANIL K. CHANDA: Sir, it hardly arises out of this question. Some of the grievances of the residents referred to works which are within the competence of the New Delhi Municipal Committee, and those matters have been referred to the Municipal Committee.

**श्री पा० ना० राजभोज :** मैं हिन्दी में पूछ रहा हूँ। इस लिए आप भी हिन्दी में बताइये। दूसरा सवाल यह है कि क्या इत स्कोम का यह अर्थ है कि देश के महान नेताओं के पुतले पार्क्स में नहीं खड़े किये जायेंगे और क्या सरकार को यह चीज एन० डी० एम० सी० को मान्य है ?

SHRI ANIL K. CHANDA: What has that got to do with this question? This is with regard to grievances of the residents of Government localities in respect of lack of certain amenities. It has nothing to do with statues of leaders.

**श्री पा० ना० राजभोज :** क्या सरकार का यह सजेशन एन० डी० एम० सी० को मान्य है ?

SHRI ANIL K. CHANDA: Sir, question No. 29 is postponed.

MR. DEPUTY CHAIRMAN: You have to ask supplementaries on Question No. 30. The Minister has already answered Question No. 30. If you have any supplementaries on that, you can put them.

SHRI ANIL K. CHANDA: Sir, shall I repeat the answer?

MR. DEPUTY CHAIRMAN: Not necessary.

**श्री पा० ना० राजभोज :** ३० के बारे में दूसरा सवाल पूछ रहा हूँ। क्या माननीय मंत्री जी कृपा कर के बतायेंगे कि वेलफेयर असोसिएशन के सदस्य कितने हैं और कितने सदस्य उनको मिले थे ? क्या यह बात सच है कि दिल्ली में जो बहुत सी कालोनीज बनी हैं वहां पर अभी तक बहुत सी बेसिक अमेनिटिज नहीं हैं ? क्या यह बात भी सच है कि मंत्री जी की भेंट में यह प्रस्तुत किया गया कि मोस्ट आफ दो क्वार्टर्स दोषपूर्ण हैं और अभी एक भी मार्केट एलाट नहीं किया गया है ?

SHRI ANIL K. CHANDA: There are so many questions. I do not know the number of members of the Welfare Association, and this question refers to . . .

MR. DEPUTY CHAIRMAN: This is about the visit of the Minister to a particular colony. So it does not arise out of it.

#### ANTI-INDIAN CAMPAIGN BY PAKISTAN

•32. SHRI JUGAL KISHORE: Will the PRIME MINISTER be pleased to state:

(a) whether it is a fact that Pakistan Government has been trying to press other Muslim countries to join the anti-Indian campaign on the issue of the recent riots in Uttar Pradesh; and

(b) if so, what steps Government are taking to counteract the propaganda of Pakistan?

THE DEPUTY MINISTER OF EXTERNAL AFFAIRS (SHRIMATI LAKSHMI MENON): (a) Yes, Sir. We are aware that the Pakistan Ministry of External Affairs has handed over a note to the Representatives of certain foreign countries accredited in Karachi which contains tendentious reports of the recent disturbances in Uttar Pradesh.

(b) We have communicated the factual material on these occurrences to all our Missions abroad. Attempts made by Pakistan to vilify India in the eyes of the Governments of these countries, with which we have friendly relations, are being counteracted.

SHRI JUGAL KISHORE: May I know what countries are approached by Pakistan in this connection, and what is the attitude of those countries?

SHRI JAWAHARLAL NEHRU: How are we to know how many countries Pakistan approached? It is for them; and we cannot get a list of countries with which Pakistan has dealt with in this matter.

SHRI JASWANT SINGH: Have we objected to Pakistan in regard to their activities of this kind?

SHRI JAWAHARLAL NEHRU: I am not quite sure, but I believe we did draw their attention to this matter.

#### MIGRATION OF TIBETANS TO INDIA

•33. SHRI JUGAL KISHORE: Will the PRIME MINISTER be pleased to state the number of Tibetans who are at present residing in India and the places where they are residing?

THE DEPUTY MINISTER OF EXTERNAL AFFAIRS (SHRIMATI LAKSHMI MENON): We do not have up-to-date information regarding the number of Tibetans who are at present residing in India. As regards Tibetan Refugees in India their total number at present is 32,296. A statement is placed on the Table of the House showing their disposition.
