

SHRI BHUPESH GUPTA: He understands English. You understand English all right.

डा० बी० वी० केसकर : जब यह नेशनल आर्काइव्स बन जायेगा, तो इन सबालों को देखा जायेगा। फिलहाल तो इस मामले में हम कुछ कर नहीं रहे हैं।

DR. RAGHUBIR SINH: May I know if special arrangements are going to be made to ensure that these films are preserved for the future in a better condition than if they are kept under the present tropical conditions?

DR. B. V. KESKAR: I am afraid the hon. Member did not carefully listen to my answer. In fact, it is said there that the Archives will be preserved in the best possible manner. In fact, we would like to get together books, etc. on how best to preserve such materials.

श्री शेरखां : क्या इस तरह का म्यूजियम सिर्फ़ दिल्ली में बनेगा या फिर मुल्क के दूसरे मुकामों में इस तरह के म्यूजियम बनेंगे ?

डा० बी० वी० केसकर : यह म्यूजियम नहीं है, यह एक तरह को रिकार्ड लाइब्रेरी है और यह दिल्ली में ही होगी, ऐसा आवश्यक नहीं है। किसी एक केन्द्र में ये बनेंगे।

डा० बी० वी० केसकर : अभी यह तय नहीं किया लेकिन जल्दी ही बता सकूंगा।

PROPOSAL TO INTER-LINK THE FILM INSTITUTE OF INDIA WITH THE INTERNATIONAL LIAISON CENTRE OF CINEMA AND TELEVISION INSTITUTE, PARIS

*138. **SHRI P. N. RAJABHOJ:** Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

(a) whether there is any proposal under Government's consideration to inter-link the Film Institute of India with the International Liaison Centre of Cinema and Television Institute in Paris; and

(b) if so, what is the purpose for which such inter-linking is to be done?

THE MINISTER OF INFORMATION AND BROADCASTING (DR. B. V. KESKAR): (a) Yes, Sir. It is proposed to affiliate the Film Institute to the International Liaison Centre of Cinema and Television Schools at Paris.

(b) By affiliating the Film Institute to the International Liaison Centre with which are associated the principal film training institutes all over the world, it will be possible for the Film Institute to conform to the internationally accepted standards from the very beginning and also to avail of the facilities for exchange of lecturers etc., with the film training institutes of other countries. This affiliation would also give a wider recognition to the Institute.

श्री पा० ना० राजभोज : क्या मंत्री महोदय कृपा करके बतायेंगे कि क्या सरकार के पास कोई स्कीम है कि पूना इंस्टीट्यूट के स्टूडेंट्स को विदेशों में फिल्म टेक्नीक का ज्ञान प्राप्त करने के लिये भेजा जाय ?

डा० बी० वी० केसकर : इसका इस प्रश्न से कोई संबंध नहीं है। It has no relation to this question; it is a different question.

MR. DEPUTY CHAIRMAN: It does not arise from this question. Put another supplementary.

श्री पा० ना० राजभोज : मंत्री महोदय कह रहे हैं कि इसका संबंध नहीं है। अगर आप बता सकते हैं, तभी मैं दूसरा प्रश्न पूछ सकता हूँ। क्या इन्स्टीट्यूट आफ पुना को बढ़ाने के लिये कोई ग्रांट दिये जाने की संभावना है ?

डा० नी० बी० केसकर : माननीय सदस्य ने यह समझा नहीं कि यह जो इन्टरनेशनल सेंटर है, यह कोई इन्स्टीट्यूट नहीं है। एक एसोसियेशन है। जितने ट्रेनिंग इन्स्टीट्यूट इस तरह के दुनिया में हैं उनको मिला कर एक एसोसियेशन बनाया गया है। यह खुद बाज़ान्ता कोई इन्स्टीट्यूट नहीं है।

MULTI-MARKET CENTRE BY E.C.A.F.E.

*140. SHRIMATI SAVITRY DEVI NIGAM: Will the Minister of COMMERCE AND INDUSTRY be pleased to state whether it is a fact that a plan has been chalked out by E.C.A.F.E. for setting up a multi-market centre for greater consumption of Asian products by Asian countries?

THE MINISTER OF COMMERCE (SHRI N. KANUNGO): Government have not received any such plan from the E.C.A.F.E.

SHRIMATI SAVITRY DEVI NIGAM: May I know if the hon. Minister is aware of a news item which has appeared in several newspapers that this type of centre has been suggested and is going to be set up?

SHRI N. KANUNGO: I have information that in the last two years, the E.C.A.F.E. is studying the possibility of increasing the intra-regional trade in Asia and that a Working

Group is working on it at the moment.

SHRIMATI SAVITRY DEVI NIGAM: What has been India's view and stand regarding this decision, and may I know whether the Government have approved it or not?

SHRI N. KANUNGO: There is no question of approval; there is no plan. But we are fully co-operating with them; one of our senior officers is a member of the Working Group.

SHRIMATI SAVITRY DEVI NIGAM: May I know how much time it will take to get this scheme finalised and establish the centre?

SHRI N. KANUNGO: It is very difficult to say because its very principle has to be accepted in detail by the various Governments of the region.

SHRI SATYACHARAN: May I know whether there is any possibility of the realisation of this scheme in the near future?

SHRI N. KANUNGO: I would not hazard a prophecy on that.

SHRIMATI SAVITRY DEVI NIGAM: May I know whether all the Governments which have to be associated with it have given their approval or not and, if not, what are the reasons?

MR. DEPUTY CHAIRMAN: The plan has not come to him at all.

SHRI N. KANUNGO: There is nothing approved yet.

SHRI SATYACHARAN: May I know whether there is any scheme under consideration before those who are already formulating it or are considering over this scheme, that they would like to associate it with the European Common Market scheme?

SHRI N. KANUNGO: No, Sir. It has nothing to do with the European Common Market scheme. It is a study group which is working on the idea itself as to how to formulate it.
