P.M.'s FLIGHT OVER AKSAI CHIN WHILE RETURNING PROM RUSSIA

- ♦123. SHRI M. S. GURUPADA SWAMY: Will the PRIME MINISTER be pleased to state:
- (a) whether it is a fact that while returning from Russia he flew over Aksai Chin which is a part of Indian territory at present occupied by the Chinese; and
- (b) if so, whether the Russian pilots obtained previous permission from the Chinese Government to fly over Aksai Chin?

THE DEPUTY MINISTER OF EXTERNAL AFFAIRS (SHRIMATI LAK-SHMI MENON): (a) The Prime Minister travelled by Soviet aircraft from Tashkent to Delhi. The route followed was over North-Eastern Ladakh and presumably the aircraft flew over the Aksai-Chin area. It was flying at a high altitude.

(b) It appears that this is the normal route for the Soviet service aircraft which come to India from Tashkent. Government of India are not aware that any permission was sought or required by the pilot of the aircraft from the Chinese Government.

MEMORANDUM

Subject:—Implementation of the recommendations of the Working Group for the Cotton Textile Industry—Setting up of Textile Mills Standing Advisory Committee to examine the causes of closure and "sickness" of cotton textile units.

A Working Group for the Cotton Textile Industry was set up by the National Industrial Development Corporation with a view to examining the extent of finances require^ for modernisation and rehabilitation of the cotton textile industry and other allied problems. The Working Group, in its unanimous report, recommended *inter-alia* that a continued examination of the causes of closures and "sickness" of textile units should be made by a small representative group consisting of top level management, top level technicians, labour representatives and Government representatives.

- II. Consequent on the acceptance of this recommendation, Government of India have decided to set up a Textile Mills Standing Advisory Committee for this purpose consisting of the following:—

THE MINISTER OF INFORMATION AND BROADCASTING (DR. B. V. KES-KAR): (a) and(b) A few isolated comments have appeared and to these, reply has been given by the Information Officer of this Ministry.

(c) There is no reason for complaint regarding the general standard of English news broadcasts. The only aspect which needed improvement was the pronunciation of Indian names and places in the English news broadcasts. Several steps have been taken in this regard including the compilation of an pronunciation exhaustive dictionary, appointment of special staff that furnishes the correct pronunciation of new words, teaching of Devanagari script to the English Newsreaders, recording of news broadcasts with a view to pointing out defects, issue of error slips, etc.
