World Bank Report on opportunities for people dependant on Forests

3722. SHRIMATI SHOBHANA BHARTIA: Will the Minister of ENVIRONMENT AND FORESTS be pleased to state:

- (a) whether World Bank report has pointed out that India is unlocking opportunites for forest-dependent-people with greater community control over forest management, income from forests could rise from estimated \$222 million in 2004 to approx. \$2 billion per annum in 2020;
- (b) whether reports indicate that community based joint forest management programme that covers 27% of the national forest areas across the country, encompassing the 85000 village communities, offers vast potential for poverty reduction and rural economic growth;
 - (c) if so, whether Government have considered this report; and
 - (d) the steps taken to implement the suggestions?

THE MINISTER OF STATE IN THE MINISTRY OF ENVIRONEMENT AND FORESTS (SHRI NAMO NARAIN MEENA): (a) and (b) Yes, Sir. This is the view expressed in the World Bank report.

(c) and (d) The National Forest Policy 1988 already recognizes people's participation in forestry as one of the main ingredients for protection and development of forests. The Ministry of Environment and Forests has already issued guidelines in June 1990 to States and Union Territories to involve local village communities in protection, management and development of forests on the principle of "care and share" within a broad framework of Joint Forest Management (JFM). The JFM programme is presently being implemented in 28 States with involvement of 99,868 JFM committees covering an area of approximately 21.44 million hectares as on 31.3.2005. The Ministry is also implementing National Afforestation Programme (NAP) Scheme during the Tenth Five Year Plan to further strengthen and operationalise JFM for rehabilitation of degraded forests and adjoining areas. The Scheme is being implemented through a two tier decentralized setup. of Forest Development Agency (FDA) at the Forest Division level and Joint Forest Management Committees (JFMCs) at the village level. As on 31.3.2006, 715 FDA projects have been operationalized in 28 States to treat a total project area of 9.24 lakh hectares through 23,750 JFMCs.
