be moved to Gwalior by June 1963. There is no proposal to shift the Bhopal branch office to Gwalior.

- (b) Yes, Sir. It is proposed to construct a new building for the office of the Accountant General, Madhya Pradesh, at Gwalior.
- (c) The new office building is expected to be located on Gandhi Road at Gwalior. The site is yet to be acquired. The probable cost of the building has not so far been estimated.
- (d) Yes, Sir. It is proposed to construct some staff quarters at Gwalior. The site has yet to be acquired.
- (e) It is too premature to estimate the cost of or the time required for the •construction of the staff quarters.

THE MINISTER OF SCIENTIFIC RESEARCH AND CULTURAL AFFAIRS (SHRI HUMAYUN KABIR): 736 Graduates, 216 Masters' Degree holders and 103 Doctorates in Pharmacy are registered with the National Register For Scientific and Technical Personnel. No precise estimate has yet been made of the requirements for personnel in this field.

(b) and (c) On the basis of the recommendations made by the Political Sufferers Committee, the Himachal Pradesh Administration had sent a proposal for grant of a total sum of Rs. 1,07,065-50 nP for giving relief to 207 political sufferers of the Unioa Territory. The proposal was returned to them for further scrutiny and detailed particulars of the political sufferers, and their further report is awaited.

. (d) There is no specific allotment of funds for relief to political sufferers. In individual cases of hardship, financial assistance to political sufferers in small amounts is given from the funds placed at the disposal of the Home Minister as his Discretionary Grant.
