**LEAVE OF ABSENCE TO SHRI

MR. CHAIRMAN: I have to inform Members that the following letter dated the 14th November, 1962 has been received from Shri Ansaruddin Ahmad: —

"I beg to state that I am suffering from a spell of great weakness due perhaps to old age. Besides, I have an attack of rheumatism with the result that I cannot move without difficulty. My doctor advises me that I should take long rest and should not undertake the strain of the long train journey from here to Delhi covering a distance of about 1,000 miles and back, in this cold weather. In the circumstances, I am compelled to be absent from this momentous session of the House and would request you and my colleagues in the House to accept my great regrets that I cannot attend and grant me leave of absence for the whole period of this session."
