THE DEPUTY MINISTER IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRI DINESH SINGH): (a) and (b) It is understood that the British Co-Chairman of the Geneva Conference on Indo-China has communicated his views on the Special Report of the International Commission to the Soviet Co-Chairman and that the Soviet Co-Chairman has conveyed his views to the British Co-Chairman. Neither the Government of India nor the Commission have received any Joint Message from the Co-Chairman.

**PUBLISHING BUSINESS STARTED BY M/S. ROY THOMSON ORGANISATION LTD.**

•149. SHRI K. V. RAGHUNATHA REDDY: Will the Minister of COMMERCE AND INDUSTRY be pleased to refer to the answer given to Starred Question No. 930 in the Rajya SEibha on the 5th September, 1962, and state;

(a) what are the terms of the collaboration agreement between the Indian associate and the British firm M/s. Thomson Organisation Limited, for starting a publishing business in India; and

(b) what are the reasons which prompted the Government to grant licence for this project, in view of the Government's earlier decision not to allow foreign publishers to enter Indian market?

THE MINISTER OF INDUSTRY IN THE MINISTRY OF COMMERCE AND INDUSTRY (SHRI N. KKNUNGO): (a) and (b) A statement is laid on the Table of the House.

**STATEMENT**

(a) The main terms of the collaboration agreement between M/s. New Horizons Private Limited, New Delhi and M/s. Thomson Organisation Limited, U.K. approved by Government are: —

- (i) The total issued capital of the company will be Rs. 25 lakhs of which Messrs. Sunday Times Publication Limited and their nominee will contribute 49 per cent of the total issued capital.
- (ii) Foreign investment would be utilised for purchase of imported plant and machinery and the balance, if any, would be invested in cash.
- (iii) The company must confine its business to the printing and re-printing of books which should be primarily scientific, technical and other standard text books. The publication of journals, magazines or news letters will not be allowed.
- (iv) The company should either agree to submit applications for royalties to the original foreign publishers on books to be published by it for disposal from time to time according to the policy in force or alternatively, accept a royalty of 7 (seven) per cent on local sales and of 10 (ten) per cent on export sales would be payable to the collaborator, the royalty being subject to tax in both cases.
- (v) The import of capital equipment as well as the import of paper, if any, shall be governed by the import control regulations in force from time to time.
- (vi) The duration of the agreement will be ten years. Extension of the agreement beyond this

period of ten years will be subject to the prior approval of the Government of India.

(b) The proposal was approved in consultation with the Ministry of Education in furtherance of their policy to make scientific, technical and other standard text books available to students in Indian Educational Institutions at reasonable prices instead of having to import such books at high cost, and with a view to build up an export market for such books.

#### **MACHINERY LYING IN THE OPEN AT OKHLA**

THE MINISTER OF INDUSTRY IN THE MINISTRY OF COMMERCE AND INDUSTRY (SHRI N. KANUNGO): (a) No, Sir. Government do not import machinery for allocation to parties intending to set up Small Scale Industries in Industrial Estates. National Small Industries Corporation only provides facilities to small scale industrial units of acquiring machinery on hire purchase basis.
