SHRI BHUPESH GUPTA (West Bengal): Sir, before you take up the business of the House, I have to make one submission. We expected from the assurance that was given when we discussed the Emergency last time in November that the Government would place before us some kind of report as to how the Emergency has been used. In our view, Sir, it has been grossly abused suppressing the Communist Party and the trade union movement. We should, therefore, have some opportunity, as one of the principal Opposition here, to prove all that I am saying on the basis of the report given by the Government itself. Sir, seven hundred of our people . . .

MR. CHAIRMAN: This is not the opportunity for that.

SHRI BHUPESH GUPTA: Why did the Government not give it? Seven hundred of our people have been arrested all over the country and even now they do not release them. would like to know when we are going to discuss this matter, because the Session is adjourning today. should like to have some opportunity to explain to the hon. Members of this House how grossly it has been abused in order to suppress a political party and to carry on political vendetta against it in the name of Emergency.

SHRI K. SANTHANAM (Madras): Sir, the report was expected only at the end of one year after the passing of the Defence of India Act.

SHRI BHUPESH GUPTA: was no such thing that it should be done at the end of one year.
