(a) the range (reception area), capacity and type of Television transmitter proposed to be set up at Bombay;

(b) the estimated initial cost of establishing the Television station with the foreign exchange component and the running cost per year of the said station; (c) what arrangements have been made to manufacture the Television receivers in India in the public sector;

(d) the proposed licence fees for Television viewers; and

(e) whether any other centres a being considered for setting up of Television units and if so, where?

THE MINISTER OF INFORMATION AND BROADCASTING (DR. B. GOPALA REDDI): (a) These details are being worked out.

(b) The estimated cost of establishing the T.V. Station at Bombay is Rs. 40 lakhs with a foreign exchange component of Rs. 28.17 lakhs. The running cost per year is estimated at Rs. 15 lakhs based on a schedule of 7 hours of telecasts per week.

(c) Proposals for the manufacture of Television Sets have not been processed as the future development in regard to Television in India is yet to be finalized and manufacture of the TV sets has no priority in the present difficult foreign exchange situation.

(d) The proposed licence fees for Television Receiver are: —

- (i) Domestic receiver Rs. 30 per annum.
- (ii) Commercial receiver Rs. 120 per annum.
- (iii) Demonstration receiver Rs. 30 per annum.

(>iv) School receiver Rs. 10 per annum.

(b) They are all engaged on contract basis for specified periods.
