CONFERENCE OF CHIEF SECURITY OFFICERS

*194. SHRI FARIDUL HAQ AN-SARI: Will the Minister of RAILWAYS be pleased to state:

(a) what were the recommendations mad_e at the Chief Security Officers' (Conference held at New Delhi in the third week of August, 1962; and

(b) whether Government propose to accept those recommendations?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI SHAH NAWAZ KHAN); (a) and (b) Chief Security Officers Conferences are held periodically to discuss organisational and day-to-day problems of the Railway Protection Force with a view to improving the over-all efficiency of the Force, and as such the question of acceptance of any recommendations by the Government does not arise.

SIXTH ALL-INDIA RAILWAY GUARDS' CONVENTION

•195. SHRI FARIDUL HAQ AN-SARI: Will the Minister of RAILWAYS be pleased to state:

(a) whether it is a fact that the Sixth All-India Railway Guards' Convention recently held Bareilly in made a demand f^or higher emolu ments and better service conditions lor railway guards; and

(b) if so, what decision Govern ment have taken thereon?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI S. V. RAMASWAMY): (a) Except for «ertam reports appearing in the Press. Government have no other information.

(b) In view of reply to part (a) of the question, this does not arise.

AUTOMATIC LIFT GATES ON LEVEL-CROSSINGS

*196. SHRI SIT ARAM JAIPURIA: Will the Minister of RAILWAYS be pleased to state:

(a) whether there is any proposal under consideration of the Railways for providing automatic lift gates at railway level-crossings in the country;

(b) if so, what is the number of levelcrossings in each railway zone which will be provided with such gates;

(c) what expenditure the scheme wil] involve; and

(d) the time by when these gates will be set up?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI SHAH NAWAZ KHAN): (a) to (d) There is no proposal for provision of automatic electric lifting barrier gates which operate automatically by approaching trains. Lifting barrier gates, coupled, which operate by mechanical or electrical means and are controlled manually from near the gate or adjacent cabin, exist at 314 level crossings and similar lifting barrier gates are programmed for installation at 207 additional level crossings. This work is expected to be executed during the next 2-3 years.

AGREEMENT ON INDIA-UNITED KINGDOM SHIPPING TRADE

•197. SHRI K. V. RAGHUNATHA REDDY: Will the Minister of TRANSPORT AND COMMUNICATIONS be pleased to state:

(a) whether the Indian and the United Kingdom Shipping Companies

have signed a *new* agreement on the share of Indian Shipping in the India-United Kingdom Trade;

(b) if so, what are the details of the agreement; and

(c) what is the share of Indian Shipping in the overall foreign trade of the country in tonnage and freight earnings?

THE DEPUTY MINISTER IN THE MINISTRY OF TRANSPORT AND COMMUNICATIONS (SHRI B. BHAGA-VATI): (a) Yes, Sir.

(b) The new .agreement prtovides for an increase in share of the Indian Shipping from 30:25 per cent to 39:475 per cent in the India-UK. trade with effect from the 1st September, 1962. The agreement will be operative up to 1971 by which time the Indian share will rise to 48'475 per cent through annual escalation at 1 per cent com mencing from January, 1963.

(c) Complete and reliable statistics are not available. But on a rough estimate Indian ships are carrying about 9-10 per cent of the overseas trade in terms of dead weight ton nage and about 20 per cent in terms of freight earnings.
