the country for growing cotton and sugarcane;

- (b) whether it has been suggested that sugar factories should not be situated in cotton growing areas; and
- (c) whether the views of the representatives of the growers and manufacturers have been invited in this regard?

THE DEPUTY MINISTER IN THE MINISTRY or FOOD AND AGRICULTURE (SHRI A. M. THOMAS): (a) No, Sir.

(b) In order to develop cotton in the newly irrigated areas, particularly in Rajasthan which possesses most congenial climatic condition for high quality cotton, it was recently suggest ed to the State Governments to put ■the maximum areas under cotton in regions which were receiving irrigation facilities from major projects. It was also suggested that in such areas no sugar factory need be allow ed but that licences for textile mills should be readily granted.

An assessment of the long distance traffic offering at such stations has been made, which reveals that there is no traffic justification for, providing stoppages to Bombay-Secunderabad Express trains at Seram and Tandur stations.
