THE DEPUTY MINISTER IN THE MINISTRY OF COMMUNITY DEVE-LOPMENT, PANCHAYATI RAJ AND COOPERATION (SHRI B. S. MURTHY): In the context of the present emergency the Community Development Programme has been re-oriented to achieve a rapid increase in agricultural production. The share of agriculture in new Stage-I Blocks has been increased from Rs. 4.5 lakhs to Rs. 5.5 lakhs out of a total schematic provision of Rs. 12 lakhs. In other Blocks State Governments have been requested to divert funds to the utmost extent possible for agricultural development subject to provision for rural water-supply being left undisturbed and facilities already provided and social services already estabilshed being maintained. The extra funds for agricultural development are to be found by effecting savings under non-agricultural and non-industrial programmes such as office expenses, purchase of jeeps and amenities programmes of lower priority.
