ducted on the same. The Supreme Court has however given rulings in two cases that certain types of production bonus cannot be regarded as 'basic wages'. The implications of these rulings are being examined.

SHRI P. K. KUMARAN: May I know, Sir, what are the industries where the 8 per cent, rate of contribution is implemented?

SHRI C. R. PATTABHI RAMAN: So far, in these industries—cigarettes, electrical, mechanical or general engineering products, iron and steel, and paper, other than handmade paper— the rate of contribution has been raised to 8 per cent., and we are constantly examining the possibilities so far as the other industries are concerned.
