## INDIAN P.O.W WITH CHINESE

- 419. SHRI SITARAM JAIPURIA: Will the Minister of DEFENCE be pleased to state:
- (a) the total number of Indian prisoners captured by the Chinese; and
- (b) how many prisoners have been released so far by the Chinese Government?

DEFENCE MINISTER OF THE (SHRI Y. B. CHAVAN): (a) Total number of Indian personnel (Army and non-Army) reported by the Chinese to have been captured by them is 3,287.

(b) 729 personnel (including 2 persons who died later) and 12 dead bodies have been handed back by the Chinese.

TEMPORARY TRANSFER OF FUNDS FROM HOUSING ACCOUNTS OF COALFIELDS

When any coalfield requires additional funds, extra allotment can be made, subject to adjustments from future allocations.

422. SHRI M. S. OBEROI: Will the PRIME MINISTER be pleased to state in how many places civil administration has been re-established in NEFA after they were vacated by the Chinese?

THE PRIME MINISTER AND MINISTER OF EXTERNAL AFFAIRS (SHRI JAWAHARLAL NEHRU): administration has been re-established in almost all areas of Subansiri and Siang Frontier Divisions; as far north as Walong in the Lohit Frontier Division and south of Sela in the Kameng Frontier Division.

## †PRODUCTION IN ORDNANCE FACTORIES

- 440 SHRI SITARAM JAIPURIA: Will the Minister of Defence be pleased to state:
- (a) what steps Government have taken to boost the defence production in the Ordnance Factories in order to meet the demands of ammunition and other necessary items; and
- (b) what economy measures have been undertaken by Government to reduce the expenditure on the manufacture of non-essential items in the said Factories?

THE MINISTER OF DEFENCE PRODUCTION IN THE MINISTRY OF DEFENCE (SHRI K. RAGHURAMAIAH): (a) All Ordnance Factories are now working multiple shifts and manpower necessary has been recruited and placed in position. Further induction of man power is now proceeding. Certain balancing plant is being added to the factories to increase their 'output further. A number of new factories are also being planned for specialised items in view of the increased requirements. Certain civil firms are also being given orders for components so as to augment the Ordnance Factories production.

(b) The production of all nonessential items has been discontinued.
