## COAL-MINE DISCOVERED IN JUNGALGALI IN JAMMU AND KASHMIR STATE

- \*354. SHRI KRISHAN DUTT: Will the Minister of MINES AND FUEL be pleased to state:
- (a) whether it is a fact that a new coalmine has been discovered in Jungalgali area in the Jammu region of Jammu and Kashmir State:
- (b) if so, whether it is a fact that the new coal-mine is estimated to contain 4' 5 million tons of good quality coal; and
- (c) what are the prospects of exploiting this new coal-mine?

THE DEPUTY MINISTER IN THE MINISTRY OF MINES AND FUEL (SHRI R. M. HAJARNAVIS): (a) The existence of deposits of coal in Jungalgali area in the Jammu and Kashmir State has been known for a long time.

(b) So far, the existence of very little coal has been proved in this area. Indications, however, are that with further drilling, it may be possible to prove sufficient quantity of coal by about the middle of 1964 for opening a mine with a capacity of 0-15 million tonnes. This mine cannot, however, be expected to commence production before the first year of the Fourth Plan.

(c) Government are considering whether the National Coal Development Corporation should develop the Jungalgali mine in the Jammu and Kashmir coalfield.

SHRI SURJIT SINGH ATWAL: May I know if some foreign personnel have been engaged for the development of this mine?

SHRI R. M. HAJARNAVIS: Not that I am aware of
