SHRI R. M. HAJARNAVIS: Certainly, we will try to decide this question as expeditiously as possible.

SHRIMATI DEVAKI (GOPIDAS): May I know. Sir. how far the Government has progressed in this matter?

SHRI R. M. HAJARNAVIS: We have, as a matter of fact, two project proposals—one by the E. N. I. and the other by the Phillips Petroleum Co.—and they are under examination of the experts of the Indian Oil Refinery.

SHRI A. D. MANI: The Minister said that the Government had not taken a decision which means that there is a proposal. May I know, Sir, with whose collaboration will this refinery be set up if the decision of the Government is in favour of the proposal?

SHRI R. M. HAJARNAVIS: Yes, Sir.

SHRI ARJUN ARORA: May I know, Sir, if this collaboration with any financial concerns will not mean financial partnership, and that the terms of collaboration will not give the foreigners fresh interest in refineries?

SHRI ARJUN ARORA: I could not get his reply.
