THE MINISTER OP EDUCATION (DR. K. L. SHRIMALI): (a) to (ci No specific recommendation in this regard has been made to the Universities. The University Grants Commission, however, is of the opinion that restriction of number is necessary to enable the colleges to discharge their functions effectively and to give adequate

- ; attention to the students enrolled. The Committee on Student Indiscipline appointed by the Commission also recommended that no college should ordinarily have more than 1000 students. The Universities, State Governments and Colleges were asked to take special note of this recommendation.
- One of the conditions of grant for assistance under the Three-Year Degree Course Scheme and the scheme for upgrading salaries of teachers is that the number of students in a college will be restricted to 1000.

BOKARO STEEL PLANT

THE MINISTER OF STEEL AND HEAVY INDUSTRIES (SHRI C. SUBRAMANIAM): (a) and (b) Preliminary negotiations were held with the U.S. Agency for International Development on the question of U.S. finance for Bokaro in May last. Following these negotiations the Agency for International Development of the U.S. Government sent a team of experts to undertake a technoeconomic survey of the projected Bokaro Plant. The team have completed their survey and then-report is awaited.

In view of this, the unanimous conclusion was that no change or relaxation should be made in the existing system and policy of prohibition in the States.

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRIMATI MARAGATHAM CHANDRA-SEKHAR): Sir, on behalf of Shri B. N. Datar, I beg to make the followinj statements:

On the 12th November, 1962, Shri Datar gave a reply to Unstarred Question No. 91 tabled by Shri Nawab Singh Chauhan in regard to the quantity of contraband bhang, ganja, wine and other intoxicants and liquormaking material seized in Delhi, and the number of persons prosecuted, etc. On rechecking these figures it has been found that there were certain errors in the statistics¹ furnished by him. I am, therefore, placing a revised statement before the House.
