## STATEMENT

(a) The purchase price of milk i3 the same in Delhi, Punjab and Uttar Pradesh. A basic price is fixed for buffalo milk containing 6 5 per cent, fat and 9 per cent, solids-not-fat and cow milk containing a minimum of 4-0 per cent, fat and 8-5 per cent. Bolids-not-fat, p?o-rata increase or decrease in price being effected according to the percentage of the fat content and solids-not-fat. The basic price varied from Rs. 15 to Rs. 22 per maund during the past 12 months.

(b) Milk is purchased through contractors and from Milk Producers' Cooperatives and State Farms.

(c) Suitable persons already in the milk trade are appointed as contractors. They are allowed a commission of Re. 0'75nP. a maund of milk supplied by them, in addition to (i) supply of ice for pre-cooling of milk; and (ii) transport of milk from the assembling centre of the contractor to the milk collection and chilling centre of the Scheme, if these are situated at a considerable distance from each etc.?]
