THE MINISTER OF MINES AND FUEL (SHRI K. D. MALAVIYA): Governement are considering various measures of effecting an improvement in the movement of coal, such as creation of dumps, movement in | full rakes instead of piecemeal movements, quick loading and unloading arrangements, etc. The State Governments are already co-operating in the implementation of some of these measures Wherever dumps are operating and planned rake movements are taking place, internal distribution is already in the hands of the State Government authorities, subject to necessary allocations by the Coal Controller.

#### PRODUCTION OF COAL BY N.C.D.C.

1074. SHRI SURJIT SINGH ATWAL; Will the Minister of MINES AND FUEL be pleased to state:

- (a) whether it is a fact that the production of coal by the National Coal Development Corporation was much less at the end Of 1961 than the original targeted estimate; and
  - (b) if so, by what percentage?

THE MINISTER OF MINES AND FUEL (SHRI K. D. MALAVIYA): (a) and (b) The National Coal Development Corporation Limited achieved a rate of production of 13-7 million tons 13)9 million tonnes) in the last quarter of the Second Plan against their target of production of 13-5 million tons (13-7 million tonnes) per year. Subsequently, however, production had to be deliberately curtailed. This was principally owing to the unusual rise in pithead stocks which increased to 1:67 million tons by 31st March, 1961. During 1961, the Corporation, therefore, produced 7-65 million tonnes. Corporation have, however, the capacity to increase production from their Second Plan collieries to the level of their Second Plan target as soon as the pithead stocks position eases.
