RULING FROM THE CHAIR RE USE OF DEROGATORY RE-MARKS IN THE HOUSE

SHRI BHUPESH GUPTA (West Bengal): Sir, I do not wish to question your ruling, but undoubtedly what is derogatory or not is a matter of opinion.

MR. CHAIRMAN: It is a matter of my opinion.

SHRI BHUPESH GUPTA: Certainly, Sir. But you will please understand the handicap from which we suffer. Suppose, some people want to declare war. I think we can make a reference that.

MR. CHAIRMAN: Mr. Gupta, the decision of the Chairman on such matters is final and the opinion is his opinion.

SHRI BHUPESH GUPTA: Have 1 disputed your ruling, Sir? No.

MR. CHAIRMAN: I am glad.

SHRI BHUPESH GUPTA: I only want to bring to your notice the handicap from which we suffer.

MR. CHAIRMAN: Please sit down. The words in question have been ordered to be expunged and they will be expunged. I will not give any further explanation.

Shri Bhupesh Gupta: You need not. I am not asking for any explanation. How can I ask you, Sir? All I say is that the reference made was not a personal one. I think it is something else. Anyway, Mr. Chairman, you have given your decision and I do not want to proceed further in the matter. But I think in such matters before giving the ruling, you may call us also to the Chamber and listen to us.

MR. CHAIRMAN: Let him have his say.

SHRI BHUPESH GUPTA: Somebody was saying something there. Anyway, what I say is that we should be given an opportunity to explain whether we made a personal derogatory remark or whether we said something else, and the circumstances which led us to do so. Then we should be allowed to show you the rules and other things. We go by certain procedures, and conventions are there. The rules are there and there is May's Parliamentary Practice and so on. This is all we request you.

Mr. CHAIRMAN: Thank you.

ENQUIRY RE MOTIONS FOR PAPERS

SHRI BHUPESH GUPTA (West Bengal): One thing more, Sir. I see the Minister of Parliamentary Affairs is just leaving. Sir, you have been good enough—and I must thank you for it—to accept my motion for discussing the flood situation.

MR. CHAIRMAN: Yes, floods.

SHRI BHUPESH GUPTA: The Minister's State has been very badly flooded. I visited it. Now, Mr. Chairman, tomorrow we are adjourning. So, I suggest that either tomorrow after the official business is over, we take up this discussion or on Saturday morning we take it up, anyway you like. I think this matter has to be discussed, for great devastation has taken place in three States and it should not be that the Rajya Sabha adjourns sine die, without giving thought to the problem of floods and discussing it, when so much devastation has taken place. We have also some suggestions to make and bring things to the notice of the Government. So, we should be given an opportunity. I hope you will kindly provide for this discussion.
