Mid-day Meal Scheme

- (b) the details of the budget allocated and targets achieved for the year 2005-06, State-wise?

THE MINISTER OF STATE IN THE MINISTRY OF HUMAN RESOURCE DEVELOPMENT (SHRIMATI D. PURANDESWARI): (a) National Programme of Nutritional Support to Primary Education (popularly called Mid-Day Meal Scheme) as revised in September, 2004 is being implemented in all States/UTs with the following main objectives:—

(i) To boost universalization of primary education of children studying in Govt., Govt.-aided, Local body schools and Centres

run under Education Guarantee Scheme and Alternative & Innovative Education.

- (ii) To improve their nutritional status.
- (iii) To provide nutritional support to students of Primary stage in drought-affected areas during summer vacation also.

The scheme envisages provision of a cooked mid-day meal with minimum of 300 calories & 8-12 grams of protein. The Central assistance is provided for the following main components:—

- (i) Supply of foodgrains (rice/wheat) @ 100 grams per child per school day from the nearest FCI godown,
- (ii) Reimbursement of actual cost incurred on transportation of foodgrains subject to a ceiling of Rs. 100 per Quintal for Special Category States and Rs. 75 per Quintal for others,
- (iii) Assistance for meeting cooking cost @ Re. 1 per child per school day,
- (iv) Assistance for provision of mid-day meal during summer vacations in drought-affected areas.

The programme is being implemented in decentralized manner with the involvement of local level agencies such as Village Panchayats, Village Education Committees, School Management Committees, Parent Teacher Associations etc. Women Self-Help Groups/Cooks, particularly, women from SC/ST community, are being engaged for cooking the meal.

(b) State-wise position of Central assistance provided to States during 2005-06 is given in the Statement (See below).

During 2005-06, target for coverage of children under the programme was fixed at 11.20 Crore. As against this, based on the enrolment data furnished by States/UTs, 11.94 Crore children are being covered resulting in improvement over the target by 74 lakh children. The feedback on the programme pioints to its positive impact on enrolment and attendance of the children.
