SHRI B N DATAR The information that we have got it is to the effect that there is no such mandir at But there is one temple of all 'Bhimkali' at Sarhan

SHRI BAIRAGI DWIBEDY May I know, Sir, whether the Government will try to asce tain again from the Himachal ' Pradesh Administration whether there is such a temple and the debris is being taken away other persons for building homes and that other constructions are taking place in the very face of the temple?

SHRI B N DATAR There have been repeated enquiries and this is the latest answer that we have got namely that there is such a temple at Sarhan and that it has been properly repaired

SHRI BAIRAGI DWIBEDY Mav I know whether there is one known as 'Jangla Bassa', which is in the vicinity of the temple, in which that temple exists

SHRI B N DATAR 'Jangla Bassa' is a different question

SHRI BAIRAGI DWIBEDY It is in the Quila and it has no separate existence

MR CHAIRMAN He says that on enquiry they have found that there is no temple at that place

SHRI BAIRAGI DWIBEDY. The Government should try to enquire again whether there is such a temple ın 'Jangla Bassa'

MR. CHAIRMAN. Is it about another temple in another place?

SHRI BAIRAGI DWIBEDY No in that very place

SHRI B N DATAR The Member must send all the information that he has We shall forward it to the State Government for enquiry

SHRI SATYACHARAN May know, Sir, whether this place mentioned here, namely, Mahakalı Mandir at Jangla Thar Quila which is Pradesh, will located in Hımachal under the Department of come Archaeology for proper upkeep?

SHRI B N DATAR My infoimation is that there is no such mandir So there cannot be any question of giving it to the Archaeological Departmen+

SHRI SATYACHARAN.

MR. CHAIRMAN: He says that the Archaeological Department will not be able to do anything if the temple is not there.

SHRI SATYACHARAN: It is mentioned that the temple dates back to the days of the Pandavas. So, it has historical importance and as such this should be looked into.

Shri LAL BAHADUR: It is true that the Director General of Tourism has written a foreword to that book and the reply that it is under consideration is because of the fact that we have asked him to explain why he wrote that foreword. He has given some explanation, but we are not fully satisfied with it. He has said that he wrote the foreword without seeing the book, the maps, etc. It is obviously a great mistake on his part. But we should get some time to look into the matter.

Shri A. M. TARIQ: There were so many books written on India and some Indian personalities just for the sake of publicity wrote these forewords. At that time we were given an assurance that they would ask their officials not to write any foreword in respect of such books which they may not first see and find out.
