genuinely, in good faith, might have gone by it. Sir, here he has brought forward this thing. It is very strange. He may interpret it in his own way. We are also entitled to interpret a broad policy. It is not a question of a broad policy. Nine licences have been given. Concrete steps. The hon. Minister might say. "These are the reasons for which we have given these licences." It is not a question of a broad policy at all. Broad policy is settled. It is mixed economy.

SHRI C. SUBRAMANIAM: It is not a question of broad policy here:

"It shall not raise questions of policy too large to be dealt within the limits of an answer to a ques tion."

That is what I stated, that it should not be discussed during the Question hour. Therefore, for him to say that I was ignorant of the Rules of Procedure of the Rajya Sabha is an insinuation. I leave it to you. Sir.

Mr. CHAIRMAN: He was really announcing his own ignorance of the Madras rules

SHBI BHUPESH GUPTA: Yes, Sir. You may think that way. How could I be knowledgeable about the Madras Assembly? You are quite right, Sir. I have never been a Member there.

MR. CHAIRMAN: That is what I have said.

SHRI BHUPESH GUPTA: You are quite right. But you, shall I submit, should not accept this interpretation of the Rules. Then, no question can be asked here.

MR. CHAIRMAN: That is not the issue. The issue was about Madras ....

SHRI BHUPESH GUPTA: You are right, Sir. I have not been for ten years in the Madras Assembly. You are right I have been ignorant. I have not been in that Assembly. The Chief Minister is not the leader. Somebody else is the leader. I never belonged to such a Ministry and I do not wish to go to the State Assembly, I tell you.
