DEPARTMENTAL CATERING ON RAILWAYS

34. Shri KRISHNA CHANDRA: Will the Minister of RAILWAYS he pleased to state:

(a) whether the departmental catering on railways is running at a loss;

(b) whe'her in order to make up the loss on departmental catering, the Railway Administration has increased the prices of articles supplied by it to authorised vendors; and

(c) if the answer to part (b) above be in the affirmative, whether the articles are being sold at railway platforms by authorised vendors at higher prices?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI SHAH NAWAZ KHAN): (a) to (c) A statement is attached.

STATEMENT

(a) Yes.

(b) and (c) Some increases in prices of articles such as sweets, namkins, etc. have become inevitable in view of the steep increase in the prices of the basic materials used in the preparation of the above-mentioned articles and not just to make up the losses in departmental catering. Even after the aforesaid enhancement, the prices generally are not high when compared to the prices charged by private catering establishments outside railway premises.
