STATEMENT

A spare air-conditioned coach has been converted into an air-cooled parcel van and is on service on an experimental basis from June, 1960 with a view to providing better facilities for transport of perishables on the Railways. The Central Food Technological Research Institute. Mysore, who were associated with the experiment, conducted tests to determine the effect of carriage of perishables in this air-cooled parcel van. The tests confirmed that the perishables carried would be in fresh condition at destination and that their carriage in the air-colled parcel van would reduce spoilage during rail transport. The tests, however, also

showed that the coach has to be run on fast trains to maintain the necessary cooling. This limits the practicabality of their use as room on the fast trains *i.e.* expresses and mails, is fully taken up.

The Central Food Technological Research Institute, Mysore, also recommended that:---

(i) The A.C. coach must be precooled before being loaded.

(ii) The A.C. coach should be run from places nearest to the growing centres so that the commodities may be loaded fresh.

(iii) The commodity loaded must also be precooled.

(iv) Arrangements should be made to provide for well-ventilated warehouses at the producing as well as consuming centres.

(v) All the commodities should be treated with wax so that their self life may be extended and spoilage is reduced to the minimum.

(vi) The defects in the methods of packing the commodities should be rectified.

Suggestions (iii) to (vi) are for trade to adopt. Suitable action on these recommendations has been taken.]
