ORE HANDLING PLANT AT VIZAG PORT

- *964. SHRI SURJIT SINGH ATWAL: Will the Minister of TRANSPORT AND COMMUNICATIONS be pleased to refer to the answer given to Starred Question No. 239 in the Rajya Sabha on the 21st June, 1962 and state:
- (a) whether it is a fact that the work of Ore handling plant at Vizag Port was allotted to M,s. Stephens-Adamson, a United States firm, as per the technical report of M/s. Rendel, Palmer and Tritton London; and
- (b) if so, what was the technical report of M/s. Rendel, Palmer and Tritton, London, on the tenders of M/s. Stephens-Adamson?

THE MINISTER OF SHIPPING IN THE MINISTRY OF TRANSPORT AND COMMUNICATIONS (SHRI RAJ BAHADUR): (a) and (b) A statement is laid on the Table of the Sabha.

STATEMENT

(a) and (b) It is not correct to say that the contract for manufacture, supply and erection of an Iron Ore Handling Plant to be installed at Vishakhapatnam Port was awarded

to Messrs. Stephens-Adamson, on the basis of the technical report of Messrs. Rendel, Palmer and Tritton, London. Messrs. Rendel, Palmer and Tritton. were engaged on an ad hoc basis only for the specific purpose of giving their expert technical appreciation of the tenders received as also of certain points requiring special consideration for the benefit of the Technical Committee appointed by Government for scrutinising the tenders and making suitable recommendations to the India Supply Mission in regard to the suitability of the various tenders. They did not specifically recommend the acceptance of any particular tender. They made a technical examination of the various merits and demerits of the various and analysed the offers received offers. In all, five offers were received as follows:--

(i) M/s. Stephens-Adamson. 135.18 (ii) M/s. Hewitt Robins 171.64

(iii) M/s. Wellman Engineering 192.18

(iv) M/s. Link Belt Co. 193.62 (v) M/s. Robert & Schaefer . 285.62

The offer from M/s. Robert and Schaefer was not technically examined by M/s Rendel Palmer & Tritton as their offer was not firm and over Rs. 90 lakhs, above the fourth highest. The other offers were technically scrutinised by M/s. Remiel, Palmer & Tritton who expressed the opinion that all the offers were technically suitable subject to some modifications

After considering the report of M/s Rendel, Palmer & Tritton, the Technical Committee came to the conclusion that the tender of M/s. Stephens-Adamson with a few modifications was the most suitable, being ลโรก lowest. It was on the recommendation of the Technical Committee that the India Supply Mission placed orders with Messrs. Stephens-Adamson.
