SHRI RAM SUBHAG SINGH: It is true that certain areas of Maharashtra have been affected by this drought. We hope that the rains will be good in the coming weeks.

SHRI C. D. PANDE: The hon. Minister has said that since the Rabi crop was already there in the market it cannot be assumed that there is rise in the prices. Sir, the forecast of the present crop is generally available at this time of the year and the estimate of production. Why this year it is not in the hands of Government?

MR. CHAIRMAN: What is the question?

SHRI C. D. PANDE: Sir, the Government's statement that the estimate of production has no effect on the prices is not correct.

MR. CHAIRMAN: That is again a statement. What do you want to know actually?

SHRI C. D. PANDE: May I know, Sir, whether the Government holds that the estimate of production has no effect on the rise in prices?

SHRI S. K. PATIL: Sir, the estimate of production is no doubt of some value to speculators. The speculative market does make some distinction in prices. So far as the physical existence of stocks is concerned, we have enough stocks to rush anywhere in any part of India. And for that reason there should be no reason as to why there should be any rise in prices.

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI S. V. RAMASWAMY) : (a) No such news items appeared in "Aryavarta", Patna dated the 8th June, 1962. However, a news item under the heading "Bhagalpur ki Chitthi" appeared in the "Aryavarta" dated the 28th June, 1962.

(b) and (c) With regard to the complaint of unrestricted ticketiess travel and nonavailability of seats for ticket holding passengers, eight special checks were conducted during the. quarter ending 30th June, 1962, and further intensive checking will be done.

Regarding the complaint of pilferage of coal, enquiries made by the Railway in August, 1962 hav_e not substantiated the allegations in the news item.
