## STATEMENT

(a) and (b) The position of selection of teachers is as follows:—

Uganda.—Applications of suitable candidates received through the State Governments/Public Schools for three Matriculate-trained teachers and one Arts Graduate teacher were sent to the Parents Association, Mbarara (Uganda) for selection. The selection was finalised by the school authorities in February, 1961.

Sudan.—Request by Khartoum University for Professors/
Lecturers in various subjects was received by the Government of India in November, 1961. Applications obtained through the Universities/State Governments in India were sent to the Khartoum Uni-

versity for selection. The University has recently finalised selection.

British Guiana.—Applications of suitable candidates for five graduate teachers for Queen's College and six Mistresses for Bishops' High School were sent to the British Guiana Government in February, 1961. The selection was to be finalised by that Government, but has not yet been finalised. No information is available on when that Government will finalise the selection.

Iraq.—Selection of teachers in English and for technical schools was completed by the Ministry of Education in 1959-60—28 teachers in English and 15 for technical schools.

Democratic Republic of Germany.—Selection of Readers and one Lecturer in Hindi for Universities in the German Democratic Republic was completed by the Government of India in 1961-62. Selection of two Readers in Tamil, one Reader in Bengali, and one Lecturer in each of these subjects is not yet complete, as sufficient suitable applications have not so far been received. Selection expected to be completed in this regard in 1962-63.
