FINANCIAL CKEDIT TO SMALL Scalb Industry

112. SHRI KRISHNA CHANDRA: Will the Minister of FINANCE be pleased to state:

(a) whether Government and the Reserve Bank of India have been urging the State Bank of India and other Scheduled Banks to liberalise the conditions for extending financial credit to small scale industry;

(b) whether Government is aware that the State Bank of India and the Scheduled Banks are still too rigid in this respect and have not changed their attitude in this connection; and

(c) whether Government propose to take any further steps for liberalising banking credit to small scale industry?

THE MINISTER OF FINANCE (SHRI MORARJI R. DESAI): (a) Yes. Government has introduced with effect from the 1st July, 1960 a scheme for guaranteeing the advances to small-scale industrial units by commercial banks and other institutions. The Reserve Bank of India has also introduced with effect from 1-1-1962 a scheme for increasing the basic quotas within which individual scheduled banks can borrow money from the Reserve Bank of India at the bank rate. According to this scheme, the quotas are increased to the extent of the outstanding advances to small-scale industrial units.

(c) The question of liberalising the terms and conditions on which assistance may be granted to small-scale industrial units is being reviewed from time to time and suitable modifications are made in the existing schemes in the light of the actual experience regarding the working or implementation of the schemes.
