# HIRE-PURCHASE OF MACHINERY THROUGH N.S.I.C.

#### STATEMENT

Delivery of machines involves following stages of processing of application after the same has been received by the National Small Industries Corporation from the Director of Industries : —

- (i) Deposit of earnest money by the applicant;
- (ii) Time taken in obtaining quotations from various suppliers;
- (iii) Receipt of import Licence;
- (iv) Period of delivery quoted by the manufacturer; and
- (v) Execution of the Hire-Pur-chase Agreement by the applicant.

Since more than one agency is involved for reaching the stage of delivery of machines by the Corporation and the time taken for processing the applications through all the stages varies with the type of machines required, maximum time taken for delivery, of machines is not the same in all cases and cannot, therefore, be indicated.
