THE MINISTER OF STATE IN THE MINISTRY OF IRRIGATION AND POWER (SHRI O. V. ALAGESAN) : (a) The Government of Gujarat were informed on 29th June, 1962, that their scheme for providing additional capacity of 250 MW at Dhruvaran would be taken up for consideration along with other Fourth Plan schemes, work on which is to commence in advance during the Third Plan period itself.

#### LOSS TO DELHI MILK SCHEME DUE TO BREAKING OF BOTTLES

\*237. SHRI DAHYABHAI V. PATEL: Will the Minister of FOOD AND AGRICULTURE be pleased to state how much loss has been incurred by the Delhi Milk Scheme due to breakage of milk bottles during the last twelve months ended June 30, 1962?

THE DEPUTY MINISTER IN THE MINISTRY OF FOOD (SHRI A. M. THOMAS) : The total value of glass milk bottles, which broke and, therefore, had to be replaced during the 12 months ended June 30, 1962, is Rs. 2,30,768.

THE MINISTER OF HEALTH (DR. SUSHILA NAYAR): According to the available information the scheme of Family Planning Communication and Research undertaken by the University of Kerala with grant-in-aid from the Government of India was approved by the Syndicate of the University.

#### EXCISE DUTY CONCESSIONS TO SUGAR INDUSTRY

\*239. SHRI CHANDRA SHEKHAR: Will the Minister of FOOD AND AGRICULTURE be pleased to state:

(a) the facilities and concessions in excise duty granted by the Government to various sugar factories in different States during 1960-61 and 1961-62 as export losses; and

(b) whether these have resulted in increasing the export; and if so, to what extent?

THE DEPUTY MINISTER IN THE MINISTRY OF FOOD (SHRI A. M. THOMAS) : On the exports of sugar, full drawback of excise duty and cane purchase tax is allowed. Since July, 1961, considering the inadvisability of raising the consumer's price, and the industry's inability to meet the losses, Government have been meeting a major part of the loss on exports.

(b) There has been considerable improvement in exports of sugar.
