SHRI C. D. PANDE: Sir, in recent years restrictions were imposed on the. issue of passports more and more because there was the problem of a large number of people going to the U.K. for labour purposes. Now that problem does not exist. May I know, Sir, if the Government will make

such rules as have existed for three or four years so that passports may be easily available as these days one has to go from pillar to post to get a passport? It takes one more than a year to obtain a passport.

SHRI JAWAHARLAL NEHRU: I doubt if the hon. Member is correct. Out of 83,923 applicants, the number given, seventy-five thousand odd were granted, five thousand odd were rejected and the balance of 3,221 were kept pending because their forms did not contain full information and they had to be sent back. Now, out of the 3,221, only 841 are pending for over one month.

SHRI BAIRAGI DWIBEDY: May I know, Sir, whether there are any cases of utilisation of forged passports in these Regional Passport Offices and, if so, what action has been taken against such a practice, and whether any employees of the Regional Passport Offices are involved in such matters?

SHRI JAWAHARLAL NEHRU: Passport offices do not issue forged passports. They issue real ones. It is the other people who forge them. This practice has been largely stopped but not entirely. Only fairly recently some further cases occurred.

SHRI A. D. MANI: May I know, Sir, what objection has Government to revert to the old practice of issuing passports for a period of five years? At present passports are issued for three years for Members of Parliament, others for only one year, some others for six months. Why can the Government not revert to the old practice of issuing passports for a period of five years and save the person concerned the trouble of going to the Passport office again and again?

SHRI JAWAHARLAL NEHRU: *I* am afraid I do not know much about this matter. I may have to enquire before I can answer the question.
